Gentlemen:

Pursuant to Section 2.2-3705.6 (11)(b) of the Code of Virginia, 1950, as amended, please be advised I, in consultation with legal counsel, have determined the records contained in Appendix A "Conceptual Design Overview (including conceptual drawings)," Appendix B "Conceptual Schedule," Appendix C "Conceptual Budget," and Crowder Construction Company's and Draper Aden Associates' Financial Statements as submitted as part of your Unsolicited Proposal Dated October 17, 2008, for the above referenced project, shall be excluded from public disclosure under the Virginia Freedom of Information Act.

This determination was reached on October 20, 2008 in accordance with the PPEA Procedures adopted by the Board of Supervisors of Prince Edward County on July 8, 2008 after finding the Sections referred to above:

1. Contain information that derives potential economic value, including but not limited to proposed techniques and processes, engineered drawings, schedules and cost estimates, the use of which by other persons may obtain value from its disclosure, which would adversely impact the proposing team;
2. Contain information which, if publicly disclosed, would adversely affect the bargaining position or negotiating strategy of Prince Edward County; and
3. Contain certain financial statements of Crowder Construction Company and Draper Aden Associates, items which are not generally available to the public through regulatory disclosure or otherwise.

With the exception of the financial statements of the proposing team and your project cost estimate calculations, which shall remain protected in perpetuity, these exceptions from disclosure shall apply until such time as a comprehensive agreement is executed.

This letter acknowledges receipt of your proposal and we appreciate your interest in working with Prince Edward County.
