ORDER FOR WRIT OF ELECTION

Upon petition of Sherry A. Honeycutt, Chairperson of the Prince Edward County School Board, it appears to the Court as follows:

That a vacancy was created on the Prince Edward County School Board effective August 10, 2017, by the resignation of Dr. Chapman H. Frazier, whose term of office as a School Board member for District 201 was to extend through December 31, 2019, and that Section 24.2-226 of the Code of Virginia, as amended, specifically authorizes the holding of a special election on the same day as a general election; that pursuant to Section 24.2-228 of the Code of Virginia, 1950, as amended.

IT IS ACCORDINGLY HEREBY ORDERED that a writ of election is hereby issued for a special election to be held on Tuesday November 6, 2018 of an individual to serve as a School Board member for District 201, beginning upon the date of qualification of the person so elected and extending thereafter to and through December 31, 2019.
