ORDER FOR WRIT OF SPECIAL ELECTION

UPON PETITION of the Prince Edward County Board of Supervisors, it appears to the court as follows:

That a vacancy was created in the position of Supervisor for District 501 Buffalo on the Prince Edward County Board of Supervisors by the resignation of C.R. (Bob) Timmons, Jr., effective January 31, 2019, whose term of office was to extend through December 31, 2021. Section 24.2-226, of the Code of Virginia, specifically authorizes the issuance of a writ within fifteen (15) days of the resignation date of a member of the County Board of Supervisors and the authorization for holding a special election to be held, following the issuance of the writ. The special election is authorized by Section 24.2-226 of the Code of Virginia, 1950, as well as pursuant to Section 24.2-228 of the Code of Virginia, 1950, as amended,

IT IS ACCORDINGLY HEREBY ORDERED that a writ of election is hereby issued for a special election to be held on November 5, 2019, for the election of an individual to serve as Supervisor of District 501, Buffalo District, of the Board of Supervisors of Prince Edward County, beginning upon the date of qualification of the person to be elected and extending thereafter to and through December 31, 2021.
