In Re: Public Participation

Chairman Fore read the Public Participation Policy, adopted at the September 2009 meeting:

Public Participation is a time set aside for citizens to share their thoughts, ideas and concerns. An official

record is made of each person's contribution tonight and will be directed to the County Administrator for

follow-up; any necessary follow-up will be noted and tracked. Follow-up may consist of an immediate

response, or planned action by the County Administrator or Board, or by placement on a future Board

agenda. Tonight's agenda cannot be changed because the public needs advance knowledge of and the

opportunity to review related materials regarding items addressed by the Board. To further assist public

information, the Board requests our Administrator, Attorney or county staff immediately correct any

factual error that might occur.

Sam Campbell, Prospect District, expressed his concern regarding potential budget cuts to the fire

departments and library, and a salary increase of 2% to County employees. He stated more time and

money needs to be spent on services for the county and less on developers.

Magi Van Eps, Tourism, gave a summary report of the tourism and marketing efforts made

recently. She stated two grants were written to Virginia Tourism Corporation for "Virginia's Retreat" and

"The Best Part of the Civil War ... The End". This area is promoted at 81 home games for the Washington

Nationals in their programs, and travel brochures for this area will dominate 17 travel plazas in

Pennsylvania to coincide with the 150th anniversary of the Battle of Gettysburg. The newest endeavor, the

Virginia's Retreat Passport, will allow visitors to have their "passport" stamped at three locations to redeem

an award at the Visitor's Center. She then presented the Board members with a brochure, a patch and a pin.

In Re: Planning & Community Development Report

Mr. Bartlett stated the Planning Commission is recommending a proposed amendment to the County's zoning ordinance. The proposed amendment creates a new section in the ordinance that provides for a Highway Corridor Overlay District that would be applied to various sections of roadway in the County. The development of a Corridor Overlay is one of the goals contained in the County's Comprehensive Plan (Comp Plan). Recommendations contained in the Comp Plan focus on access management, protection of viewsheds and the development of a corridor design policy manual to be used as a policy guide.

Mr. Bartlett said that as stated in the proposed amendment, the intent of the Overlay District is to protect scenic beauty and viewsheds, enhance levels of transportation service along the major County access roads, and increase property values. Specific attention has been given to access management, multimodal transportation, landscaping and site design. An illustrated design guide, which has no legal force, has also been developed.

The Overlay District does not change the underlying Zoning Map nor does it reduce the dwelling

unit density. It also does not apply to permitted agricultural or residential uses.

In Re: County Administrator's Report

Route 786 Update – Mr. Bartlett stated there have been some changes in the status of Route 786 Project since last week. The construction company has reworked and addressed the issues at the storm water ponds. He said VDOT informed the County that they are now willing to open the road and VDOT will maintain the road and guardrails, but not the drains and ditch line.

Mr. Bartlett stated the Performance Bond with the contractor will remain in place and there is a one-year guarantee on the road once it is complete, to include the right-of-way area (storm water basins, the slopes); the guarantee is on workmanship and materials.

Mr. Bartlett questioned the Board regarding setting a date to open the road and the ownership of the storm water ponds. He said it takes approximately three days to have the signal lights activated.

Mr. Bartlett reported the County Staff held discussions with representatives from VDOT concerning future development adjacent to Route 786 and the ability to relocate the storm water ponds if a developer's preferred site plan called for such relocation. VDOT recommended the County maintain ownership of the storm water ponds if there is the possibility the ponds could be moved in the future. Once ownership of the ponds is transferred to VDOT it can take as much as a year to have the ownership reversed, if VDOT even agrees to such a request. The engineers stated there is little expense in the upkeep of the ponds once they are stabilized and there is minimum risk of a failure of the ponds. Currently, the County owns the storm water pond located on Dominion Drive. Our experience to date has shown there is little cost to the County in maintaining such ponds.

The advantage to owning the ponds would be it would allow greater flexibility for the County when dealing with any future developer and moving such ponds to the rear of any development would increase the developable property adjacent to the road. The risk of ownership is the annual maintenance (mowing) and the need to make any repairs.

experiencing and normal growth in the Revenues. He stated there is a difference of less than \$20,000 from

projected collections this year than what is recommended for next budget year.

In Re: Review of Expenditures

Mr. Bartlett stated he recommends a decrease of \$24,403 in the contribution to the Farmville

Volunteer Fire Department, which takes into account the Fire Program Funds the Department receives from

the Town of Farmville.

Mr. Bartlett then recommended a decrease in funding to the Library by \$25,597 from the FY 13

budget or \$40,918 when compared to the Library's request of \$207,507. The decrease was recommended

to align the County's contribution with funding provided by the Town of Farmville. Additionally, the

Library stated in their application that FY10 was used as their base year and they asked for an additional

\$12,507, this amount would be \$152,059 + \$12,507 = \$164,566. Mr. Bartlett recommended the amount

provided to the Library in FY14 be the same as in FY11 or \$166,559.

Mr. Bartlett then discussed other various expenditures and reductions, for example, \$155,139 was

paid back to the state in FY13 but that expense will not exist in FY14; the expense of \$200,000 to purchase

a garbage truck; \$200,000 for the reassessment; \$1,150,000 to close the landfill cell; and \$700,000 for the

regional jail. Mr. Bartlett said the first RFP for the medical services for the jail would increase costs by

\$400,000 annually.

Discussion followed on the YMCA FY14 Summer Program and the funding provided by the County over the past few years.
