At a special meeting of the Board of Supervisors of Prince Edward County, held at the Court House,

Chairman Fore called the reconvened meeting to order at 3:00 p.m. stating its purpose is a work

session on the Prince Edward County School Budget and the County Budget.

In Re: Approval of FY 14 School Budget

Chairman Fore stated:

With the Board's consent, I would like to open our meeting today with a few thoughts

that I think recap the results of our budget work sessions and summarize this Board's effort to

draft a County budget that best serves the needs of all of our citizens. Since January this Board

has met nine times. Two of those nine were with the School Board, to discuss the School FY14

Budget.

The budget schedule set by the Board calls for the approval of the County budget this

afternoon. Doing so keeps our historic timeline of approving a school budget by May 1, which

enables the School Board to make its decisions for the coming school year.

At the start of the budget process the Board provided the County Administrator only two

very broad guidelines to follow. First, if at all possible do not increase tax rates and second,

maintain service levels to county citizens. We felt that the economy was still weak and many of our residents simply cannot afford to pay any more in local taxes.

As the economy has slowly improved; so have state and local revenues. For the first time in several years, the state did not make cuts to funds they provide to Prince Edward County. In fact, the state is providing additional funds. But the additional funding is not nearly enough to offset the other cuts we have experienced or the costs the state has pushed from its budget down to ours.

Some of the increased funding provided by the state actually increased County costs instead of reducing it. For example, the state provided funds to increase the state approved salary of employees in the constitutional offices by 3%. The total increase provided to Prince Edward for this salary increase is approximately \$45,000. But to implement a 3% across the board increase for the employees of the constitutional offices, actually costs \$86,000 of which Prince Edward County pays \$41,000. The same concept applies to the Schools. The state provided funding to increase salaries of SOQ positions by 2%. But to provide such a raise across-the-board, as the School Board desires, increase Prince Edward County's cost by almost \$131,000.

To help offset the loss in state and federal revenues over the last few years the School Board requested the Board of Supervisors provide almost \$1.4 million in additional local funding. This amount would have required a real estate tax increase of nine cents. Our citizens simply cannot afford that kind of increase and we, as a Board, declined to provide that amount.

But the Board is ready to provide an additional \$240,148 above level funding. This amount will allow the School Board to provide a 2% across-the-board raise, pay for a 5.8% increase in the cost of health insurance and provide the local match required to hire a mandated early reading specialist. That will bring the amount of local funds provided to the schools to \$8,346,800. To bring that into perspective, for the FY14 budget, it is projected we will collect \$6,582,002 in real estate taxes. This fact plainly shows that education is still the number one priority in the County budget.

The single largest change in the FY14 budget compared to previous years involves funding for the regional jail, which is a brand new expense. We have been fortunate that in the past Prince Edward has not had to provide tax dollars for the operation of the jail. The loss in state revenues coupled with a loss in revenues from two Counties when they built their own jail resulted in the Jail losing over \$2 million in revenues. The result is a new cost of \$700,000 for the citizens of Prince Edward. This was the single greatest challenge in this year's budget.

To follow the Board's direction, Mr. Bartlett presented us with a proposed budget that provided level funding for the Schools and most of the non-profit agencies. His budget did contain cuts in many county departments and in some cases to a few of the non-profit agencies to which we provide funding. There was no proposed tax increase. It was made clear to the Board that the budget presented, if approved, would mean the County would start next year's budget process with a deficit of approximately \$525,000. That was deemed acceptable because of a combination of a healthy fund balance and the almost certain prospect that the Quarry would start operation bringing in new revenues. Additionally, there appears to be a reasonable chance that the final cost of the Jail to the County would be less than the amount budgeted.

During the budget work session process, the Board has indicated it desires to return most of the recommended reductions to the non-profit agencies and some of the reductions in departmental budgets. The budget resolution before you today includes an additional \$469,181 in expenses from the budget initially presented to the Board.

We have discussed these issues much. There is hope that several items that are in a state of flux at this time, such as the Jail and the Quarry will either increase revenues or decrease expenses. It is anticipated that those items added to what appears to be a growing economy and growing local revenues will help overcome this deficit.

With that said, I will first entertain a motion for the adoption of the FY 14 Prince Edward County School Budget.

Supervisor Wilck made a motion, seconded by Supervisor Simpson, that the FY 14 Prince Edward County School Budget be approved as follows:

<u>School Fund</u> – The total for the School Fund is \$25,097,135, of which \$8,346,800 is local revenue as a transfer from the County General Fund.

<u>School Cafeteria Fund</u> – The total for the School Cafeteria Fund is \$1,181,676, of which \$0.00 is local revenue as a transfer from the County General Fund.

This provides for an overall FY 14 Prince Edward County School Budget in the amount of \$26,278,811.
