At a special meeting of the Board of Supervisors of Prince Edward County, held at the Court House,

thereof, on Tuesday the 27th day of April, 2010; at 4:00 p.m., there were present:

Chairman Fore called the reconvened meeting to order, stating its purpose was regarding the

Prince Edward County School Budget and for a budget work session.

In Re: FY11 Prince Edward County School Budget

Supervisor Simpson made a motion to approve the Prince Edward County FY11 School Budget in

the amount of \$26,698,807 as presented with the caveat that any carry-over funds be kept in the General

Fund until the School Board presents a plan for how the funds will be spent on the athletic fields. The local

contribution to the schools for FY 11 is \$7,913,044.

Discussion followed on how the funds are appropriated to the schools. Mr. Bartlett said it is

appropriated annually by category, on motion of the approval of the school budget. Discussion followed.

Chairman Fore then asked for the vote on Supervisor Simpson's motion to approve the Prince

Edward County FY 11 School budget as presented; the motion carried:

Mr. Bartlett said Kenneth Clarke is a native of Prince Edward County, born in 1948, and was

killed in hostile fire zone in Viet Nam in 1969. He said Mr. Clarke's home of record is Richmond, but he

was named as Platoon Leader of Recruits from Farmville, VA. He grew up near Moore's Ordinary Road

on the Prince Edward County side of the road.

Supervisor Campbell asked another Board member to attend a meeting at the Pamplin Fire Department with the Prince Edward Firefighters Association to discuss possible fire department funding

changes; Chairman Fore and Mr. Bartlett agreed to attend.

Supervisor Wiley said constituents expressed their support of a two-cent to four-cent increase in

the real estate tax rate provided the schools remain level-funded.

Supervisor Jones suggested a two-cent increase in property taxes and a \$10 increase in the Motor

Vehicle License Tax, which would raise \$190,000. Mr. Bartlett said that would leave a deficit of \$110,000

from what the four cent tax increase would raise, but there is a \$180,000 balance in the recommended

budget and the budget could absorb that amount.

Supervisor Gantt asked about transferring accounts from a bank with higher charges to one that

has lower fees. Mrs. Mable Shanaberger, Treasurer, said she is waiting for a proposal to come from BB&T

to determine which financial institution can offer the best service and best price to the County. Further

discussion followed.

Ms. Cindy Wahrman, Finance Director for Prince Edward County Schools, asked for clarification

on what information the Board of Supervisors will require at the quarterly meetings.

Supervisor McKay said the Board would like reports on the progress the school is making; he said

the Board would be glad to help in any way it can. Supervisor Wilck added he would like to know how the

state mandates are working. Mr. Bartlett asked the School Board to share any information and

requirements received from the state.
