involved in litigation in Campbell County, and asked if other companies were notified to do the

investigation. He said he is concerned about the credibility and actions of Joyce Engineering and asked the

Board to not hire Joyce Engineering based on their track record.

PROTOCOL FOR BOARD OF SUPERVISORS COMMENTS

The Board of Supervisors sets aside ten (10) minutes near the beginning of each

regular board meeting for each member of the Board of Supervisors to respond to comments made by citizens during "Public Participation," if he/she so desires.

This is an opportunity for each individual member of the Board to express

his/her own personal opinion in response to a citizen's concerns on matters of

public interest.

"Board of Supervisors Comments" is not designed to allow debate between

Board members and citizens.

The Chairman of the Board will establish the order of speakers and will

maintain decorum.

- Each Board member shall be allotted an opportunity to speak for a maximum of one (1) minute; unless additional time is yielded by another member of the Board. In the event a Board member or member(s) shall be absent, unallocated time shall not be allocated to Board members in attendance.
- Following each Board member's comment period, the remaining two (2)
 minutes shall be set aside for appropriate response, and shall be divided equally
 between those members of the Board wishing to respond, and as directed by the
 Chairman.

In Re: Board of Supervisors Comments

Supervisor Ward expressed his concern regarding an article regarding Joyce Engineering and Campbell County, and regarding the process for the proposed land sale of the property located on Route 628. He said he does not want the Board to make the same mistakes it had been criticized for in a previous land transfer.

Supervisor McKay asked for clarification on the ownership of the Poplar Hill land, and if the County ever owned that land. Chairman Fore said the County never owned it.

Supervisor Wiley said she would like to know more about the Joyce Engineering firm.

Supervisor Moore asked if the proposed contract has been properly drawn up. Mr. James Ennis, County Attorney, stated he has not seen the proposed contract.

Chairman Fore said he wished to clarify the information about what had been called "the contract." He said the interested purchaser presented the proposed contract when he approached the Board regarding the property. Chairman Fore said if the Board was to transfer the land to the IDA, the IDA would then act as negotiator; nothing has been approved at this time. Further discussion followed.

Supervisor Ward said the IDA voted to accept the contract prior to the Board's approval to transfer the land to the IDA.

Chairman Fore said the IDA voted to accept the property if the Board decides to transfer the property to them, not the proposed contract, and asked further discussion be saved for the public hearing portion of the meeting.

In Re: Highway Matters

Mr. Alan Leatherwood, Resident Highway Engineer, said the final right of way has been obtained for the Hidden Lake Road project; it will be advertised in December 2009 or January 2010 to begin work in April 2010.

Mr. Leatherwood said the Route 460 Highway East project is in progress. He said bids were received April 29, 2009; the apparent low bidder for the pavement rehabilitation job on the last 2 ½ miles of 460 eastbound to the Nottoway County line bid a cost of approximately \$2.5 million. Mr. Bartlett said the project had been estimated at \$4.4 million, and asked what happens to the money remaining. Mr. Leatherwood said he was unsure but expected it would be returned to the state for redistribution. He said the project is expected to begin in a month and a half. Mr. Leatherwood then said Prince Edward County will also receive additional bridge funds for Sneads Road, Miller Lake Road, Chapel Road, and Bell Road.

Supervisor Ward asked about the revenue sharing program; Mr. Leatherwood said the availability of revenue sharing has not yet been determined; there may be a limited amount. Mr. Bartlett said other projects that had been funded with revenue sharing, and that if they came in under budget, those funds could be available. Mr. Leatherwood said any money that is left over from revenue sharing funds can be

applied to another revenue sharing project. He said one project in the County had additional money left

that can be applied to an additional project. Mr. Bartlett asked if the funds saved on the Via Sacra project

will be sent back to the state, or if it would be retained locally. Mr. Leatherwood said the County could

request the funds be added to another project. He said the total project was \$981,000 and came in way

under, with about \$300,000 state funds left over. Supervisor Moore asked which areas the stimulus funds

will be applied. Mr. Leatherwood said the stimulus funds will be applied to the bridges, and pavement

rehabilitation projects.

Chairman Fore said the Route 15 project has been pared down due to the lack of available funds.

He said a verbal agreement has been reached on how to best spend the funds with a re-working of the

Route 15 project.

In Re: Public Hearing – Secondary Highways Six-Year Plan

Chairman Fore announced this was the date and time scheduled for a public hearing on Prince

Edward County's Six-Year Plan for Secondary Highways. Notice of this hearing was advertised according

to law in the April 29, 2009 and May 6, 2009 issues of THE FARMVILLE HERALD, a newspaper

published in the County of Prince Edward. The floor was opened for public input.

Chairman Fore said the County has been drastically reduced in funding. He said that two years

ago, the County received \$1.3 million; now the County will receive just \$265,000. Mr. Leatherwood said

the allocation received for six years is roughly what the County had previously been allocated in one year.

Chairman Fore said the amount of funding will reduce the maintenance on the roads even more,

including the grass cutting, trimming of bushes and trees, and will be done when a safety issue arises.

Mr. Leatherwood said the construction funds have been drastically cut, but maintenance has been level-funded. He said Priority 1 is Route 638, reconstruction from the east corporate limits, from Persimmon Tree Fork Road to a half mile east of Route 748; Priority 2 is Route 643 (Back Hampden-Sydney Road) from Farmville Town limits to the bypass at Route 644; Priority 3 is Route 619 (Lockett), the dedicated bridge fund, replace the existing bridge and approaches at Saylor's Creek. He said the unpaved road portion will be Route 751, Hidden Lake Road, which will be able to go to advertising this year; and Route 601, Aspen Hill Road, from Route 460 to 1.3 miles north of Route 460. Mr. Leatherwood said Route 626 will not be in the final plan, and the other portion of Hidden Lake Road has been dropped from the plan due to lack of funding.

There being no one wishing to speak, the public hearing was closed.

WHEREAS, Sections 33.1-23 and 33.1-23.4 of the 1950 *Code of Virginia*, as amended, provides the opportunity for each county to work with the Virginia Department of Transportation in developing a Secondary Six-Year Road Plan; and

WHEREAS, this Board had previously agreed to assist in the preparation of this Plan, in accordance with the Virginia Department of Transportation policies and procedures, and participated in a public hearing on the proposed Plan (2009/10 through 2014/15) as well as the Construction Priority List (2009/10) on May 12, 2009 after duly advertised so that all citizens of the County had the opportunity to participate in said hearing and to make comments and recommendations concerning the proposed Plan and Priority List; and

WHEREAS, W. A. Leatherwood, Residency Administrator, Virginia Department of Transportation, appeared before the Board and recommended approval of the Six-Year Plan for Secondary Roads (2009/10 through 2014/15) and the Construction Priority list (2009/10) for Prince Edward County;

NOW, THEREFORE, BE IT RESOLVED that since said Plan appears to be in the best interests of the Secondary Road System in Prince Edward County and of the citizens residing on the Secondary System, said Secondary Six-Year Plan (2009/10 through 2014/15) and Construction Priority list (2009/10) are hereby approved as presented at the public hearing.

In Re: Public Hearing – School Board Appointments

Chairman Fore announced this was the date and time scheduled for a public hearing on the Prince Edward County School Board Appointments. Notice of this hearing was advertised according to law in the April 29, 2009 and May 6, 2009 issues of THE FARMVILLE HERALD, a newspaper published in the County of Prince Edward. He said at the April Board meeting, the candidates presented were Osa Sue Dowdy, District 401; Beulah M. Womack, District 401; and Ellery Sedgwick, District 701. The floor was opened for public comment.

Eva Bland expressed her support of Osa Sue Dowdy for appointment to the School Board, and said Mrs. Dowdy has the ability, knowledge and expertise to represent District 401.

Dr. Osa Sue Dowdy said she is honored to have served the past eight months on the School Board and expressed her interest in continuing to serve in that capacity. She said she wishes to use the knowledge obtained at the conferences she has attended to ensure the school maintains the state policies.

Raymond Dowdy expressed his support of Dr. Osa Sue Dowdy, and that her experience in business and educational systems are a benefit to the School Board.

Stanley Lyles also expressed his support of Dr. Osa Sue Dowdy.

Katharine Smith expressed her support of Dr. Osa Sue Dowdy and said her emphasis has always been on educating youth.

A citizen said he supports Dr. Osa Sue Dowdy and spoke highly of her character.

Queen Lyles said Dr. Osa Sue Dowdy is already serving on the School Board and is an excellent choice because of her educational background and her concern for the County.

There being no one else wishing to speak, Chairman Fore closed the public hearing. He stated the Board will appoint the School Board members at the June Board meeting with the terms to begin July 1.

In Re: Public Hearing – Conveyance of County Land to IDA

Chairman Fore announced this was the date and time scheduled for a public hearing on the Conveyance of County Land to the Industrial Development Authority. Notice of this hearing was advertised according to law in the April 29, 2009 and May 6, 2009 issues of THE FARMVILLE HERALD, a newspaper published in the County of Prince Edward.

The County of Prince Edward owns two parcels (58 acres and 65 acres) of land totaling 123 acres, more or less, located on State Route 628 (Zion Hill Road), adjoining the Prince Edward County Public Schools. The property was purchased in August 2003 for a cost of \$490,000 from Luck Stone.

A proposal was received from Prince Edward Development Corporation to establish Granite Falls Inn and Conference Center, and the Corporation is interested in purchasing approximately 95 acres on the southern (lower) end of the property. The purpose of conveying the land to the IDA is to facilitate the negotiations for the purchase of the land by the developers of Granite Falls Inn & Conference Center and for the relocation of Route 628.

Chairman Fore said it has been a vision of the Board to close a portion of Route 628 on the east side of Route 15 from the stop light to Poplar Forest Apartments, and create an Alternate Route 628 farther south on Route 15 to join Route 628 behind the school. Chairman Fore said the traffic increase in the past five or six years on Route 628, with the growth along Routes 628 and 630, has become tremendous, presenting a daily challenge for the students to cross the road. Chairman Fore said a student may be hurt while transferring from one side of the highway to the other to attend school. He said the Alternate Route 628 project could be a part of the offer, and that the IDA could present it during the negotiations. The floor was opened for public input.

Kenneth Jackson, Leigh District, said, "I've already introduced myself; I'll go right on into the issue. I want to clarify something, when I said about Poplar Hills, I wasn't talking about land. Poplar Hills was supposed to be developed over 1,000 homes by now, which was supposed to generate taxes and revenue for the County which would have helped the citizens with roads and things. That's what I was talking about. But, as we are well aware, on April 14th there was a land sale and transfer proposal put before this Board which was tabled, and by our Attorney's own admission, it was more restrictive than what the state allows, which didn't mean that it was illegal, it just meant that things like this couldn't happen. Then, several citizens [have] now objected to the land to the transfer of the land. Now, that's where this contract does come into play. IDA brought it to you, you appointed IDA. As citizens, we respect people you appoint, but we also expect them to do their job and look. So, before the transfer even came, this should have been looked at. Whether it was just a preliminary contract or whatever. And you would have seen it wasn't right. One, we're losing money on the land, we're not counting the timber, and now we're here to transfer land, and it looks like the same thing that happened before – it's a push-through of land. As we can tell by on [Route] 460 westbound. We cannot do this. The whole idea of selling off "surplus land" is to generate revenue to do things for citizens. Education. Roads. Infrastructure. As well as bring business. This contract right here says there might not be a business. As I said, we've seen the newspaper and there's a pretty picture, but right here it says that there hasn't even been a feasibility study. So for you to transfer - and if it's really not that big of a hurry to transfer - I would ask you as our Supervisors, as the government that we elected, to do what's right for the people, and what's best for the people to think. Let's go back and critique this and get a better one, and then we'll look at proposing -

closing – selling the land. But not sell it like this, or not sell it and you don't even know what you're selling it for. Or transfer. It's not a necessity right now or at this moment. The other thing, too, that you keep saying is the schools. There are people and citizens right in this room who went to those schools for over twenty years. Who were in this county before half of you were. They didn't have a problem. I drive down that road during school times, and I have enough sense to stop for those kids. So do most of the drivers around here. Do not go screaming fire in a crowded building just to get this through. And I don't care how many friends, constituents, comrades you have, your citizens come first and there's 18,000 of us in this county, plus. So before you make this plan and go on and transfer the land and make citizens feel like you're not going to listen to them, think about what you're doing, and let's slow down a little. If you're going to do it, do it right and do what's best for the citizens."

Jack Houghton, Farmville District, said he lives a mile from the County schools and from the land under consideration. He said he supports legitimate economic development, and understands why and how it is done, and how it should be done. He said he is not anti-economic development, but not everything characterized as economic development is good for the citizens or the community. He said the end result is to protect and advance the public interest in the form of prudent investment of scarce public resources, and the creation of tangible and measurable economic benefits. He said he understands the documents are preliminary in nature, and his comments are based on the documents he reviewed in the Administrator's office. Mr. Houghton encouraged the Board to "trust but verify," and expressed his concern over the similarities between the Granite Falls Inn and Conference Center and the Poplar Hill development. Mr. Houghton said the proposed contract calls for the purchase price to be less than what the County paid for the land. He said the site is located in a well-recognized growth corridor with great, long and immediate term development potential, with existing utilities available and considerable timber resources. He said the developer proposes the County re-zone the parcel from General Agricultural to Commercial which would potentially significantly add to the value of the property. Mr. Houghton said this parcel is a valuable taxpayer-owned asset and should be carefully managed and protected by the Board of Supervisors for the public good, and its value has yet to be determined. He added while the facility would be a great thing to have in the County, there have been two other similar attempts which have fallen

through. He said once the property is transferred to the IDA, the proposed contract is scheduled to be signed on May 14, and the land would be lost with no recourse and few protections.

Mr. Wade Bartlett, County Administrator, said the May 14th date is in the developer's schedule, not that of the IDA or the County.

Discussion of the proposed contract followed. Mr. Houghton said solid facts, figures, specific dollar amounts and quantified benefits are necessary, and the County government shouldn't subsidize deficiencies in the developer's market feasibility study, and asked the Board to exercise a cautious approach.

James Ghee said he wished to remind the Board that the purpose for the purchase of the property had been to provide the space to expand the educational campus for educational facility needs. He said the transfer of only 95 acres may still impact the future needs of the educational facility.

There being no one else wishing to speak, Chairman Fore closed the public hearing.

Supervisor Ward said he dislikes the rush there seems to be, especially for a project as extensive and complex as this project. He said the amount of land conveyed is important, as is knowledge of the principals of the Prince Edward Development, LLC. He said the County purchased the land in 2003 for \$490,000 and they are offering \$380,000 which is less than the purchase price. He added the Board voted for the previous County Administrator to conduct a timber cruise on that land which had never been done. He asked if the land has been appraised, and said the developer is asking the County to change the zoning, so the County should then sell it as commercial land. Supervisor Ward also asked about the cost to relocate Route 628 and who will pay for it.

Chairman Fore said that the proposed contract presented by Mr. Bob Fowler offered \$380,000 for 95 acres +/- and in addition, will pay 55% of the cost of moving the highway. He said the County would be responsible for the remaining 45%. If the State re-establishes the Highway Revenue Sharing Program, in theory, the County could take the developer's 55% and use it as matching funds to pay the County's 45% to pay for the highway.

Further discussion followed on the terms of the proposed contract.

Chairman Fore said the land is in two tracts; one portion is directly behind the middle school, which consists of 35-40 acres and are the prime building portion of the 123 acres purchased for future

expansion of the school. He said across the property to the east, the property is rougher and continues to degrade to the creek. Chairman Fore said Mr. Fowler's proposal spoke of developing the roughest of the terrain with access from Route 15 and Dominion Drive. He said it would bypass the school and would be far enough away from the school to be safe.

Chairman Fore said the IDA is the "arm of the Board of Supervisors," and by using the IDA to negotiate, it takes politics out of the deal. He said the IDA has no more power than what the Board of Supervisors gives. He said the Board of Supervisors sets the criteria for the negotiations. After the IDA negotiates with the developer, the proposed contract is brought before the Board and the public, is approved, denied or sent back for more negotiations. He said the timber cruise and appraisal can be included in the negotiations, and it is incumbent upon the Board to set a time limit that if the deal doesn't go through, the land would revert back to the County. He said the IDA needs to be allowed to do its job.

Supervisor Jones said a change in zoning would require a public hearing, and if denied, the project would die. He said stipulations could be set for the IDA to negotiate, and anything can be changed by the Board. He added the IDA did a good job in negotiations for the Lowe's property, and encouraged the citizens to attend the meetings and give input at the appropriate times. He added this project could look out for the education and roads, and looks to the safety of the children at the schools. He said the land in that area is rough terrain; of the 123 acres, only 60 can be developed and the County will keep 35 acres of the most favorable land.

Discussion followed on the need for an appraisal and timber cruise.

Chairman Fore said he agrees with Mr. Houghton and the project appears workable. He said the County could use the facilities, as all 400 beds in the County's motel system were full due to the graduation ceremonies at Longwood University and Hampden-Sydney College, and a conference center would be beneficial as well. He said the IDA is diligent enough to come up with a deal with the developer that would be beneficial, not only in dollars to the County and the citizens, but in dollars in the future for tax to improve the tax base, and a physical facility that could be used to the utmost for the citizens.

Supervisor Jones made a motion to convey two parcels (58 acres and 65 acres) of land totaling 123 acres, more or less, located on State Route 628 (Zion Hill Road), adjoining the Prince Edward County Public Schools to the IDA.

Supervisor Ward made a substitute motion to delay the transfer of land until the June 2009

In Re: Award of Audit Contract
