### WELCOME AND INTRODUCTION

The meeting was called to order at 10:01 a.m. There was a brief round of introductions, then Mr. Fortune began an overview of the project and the process involved.

### OVERVIEW OF HAZARD MITIGATION AND EXPLANATION OF PLANNING EFFORT

Mr. Fortune gave a handout to the group outlining the project and the process (see ATTACHMENT #2). This project is being funded by a Pre-Disaster Mitigation (PDM) grant from FEMA. A non-federal match is required on the grant. The former Piedmont Planning District Commission completed a regional Hazard Mitigation Plan – covering all of the localities within Planning District 14 with the exception of Amelia County – in December 2005. Amelia County completed its own plan shortly after that. As part of this update process, both plans will be combined into one.

As per federal requirements, the plan needs to be updated every five (5) years for the covered localities to remain eligible for certain types of FEMA funding. They include:

- o Pre-Disaster Mitigation (PDM) Grant Program
- Hazard Mitigation Grant Program (HMGP)
- o Flood Mitigation Assistance (FMA) Program
- o Repetitive Flood Claims (RFC) Program
- o Severe Repetitive Loss (SRL) Program

Mr. Fortune also handed out a tentative project schedule (see ATTACHMENT #3). He said that the CRC hopes to have this project completed by December, but it could very well go into the first half of 2010. Mr. Coates said that should not affect the availability of localities to remain eligible for the above-mentioned types of funding, stating that if a locality applies before the Plan update is completed and the project is approved, then FEMA would allocate the funding but a grant agreement would be signed only after the Plan update is completed.

### <u>DISCUSSION OF WHAT WILL BE EXPECTED OF THE PROJECT ADVISORY</u> COMMITTEE, AND OVERVIEW OF PUBLIC MEETINGS

Mr. Fortune went over what is expected of the Project Management Team. With the Plan update, participating localities (with the exception of Lunenburg County) will be contributing in-kind (staff hours) for the match on this grant. Therefore, Project Management Team members are being asked to assist with data collection and reviews. Additionally, as with the initial Plan, Project Management Team members will also be asked to review materials and provide feedback.

Mr. Fortune said timesheets would be sent to all Project Management Team members, so that they will be able to track their time for the purposes of documenting in-kind match.

Mr. Fortune said the Project Management Team could expect to meet at least 4-5 times during the process. This will include at least two (2) meetings to which the public and regional stakeholders will be invited. To get full public participation, CRC staff will make presentations to local governing bodies during the process. In addition, the draft Plan will be made available for public review and comment when it is ready.

### OTHER ISSUES, ADJOURNMENT

Mr. Leeds inquired about digital flood data. Mr. Fortune said that he expects digital flood data to be available for most or all of the localities covered under this Plan.

Mr. Coates reiterated that incorporated towns would need to participate to some level. This includes having at least one mitigation action in the Plan as it is updated.

The meeting was adjourned at 10:40 a.m.

### CRC REGIONAL HAZARD MITIGATION PLAN PROJECT OVERVIEW

### Project synopsis, federal requirements

- The localities in Planning District 14 are covered by a FEMA-approved Hazard Mitigation Plan.
  - o Amelia County is currently covered under its own Plan.
  - The other localities in Planning District 14 are covered under the Piedmont Regional Hazard Mitigation Plan (adopted in 2005).
  - As part of this process, both Plans will be combined into one (1) Regional Plan.
- Plan identifies strategies and actions localities can implement before disaster strikes, to mitigate (lessen) the impact of those disasters when they do occur.
- All localities, in Virginia as well as across the United States, are required to be covered by a FEMA-approved plan as per the Robert T. Stafford Disaster Relief and Emergency Assistance Act, as amended by the Disaster Mitigation Act of 2000 (DMA2K).
- Being covered under a FEMA-approved Plan allows localities to remain eligible for certain types of FEMA grant funding specifically:
  - o Pre-Disaster Mitigation (PDM) Grant Program
  - o Hazard Mitigation Grant Program (HMGP)
  - o Flood Mitigation Assistance (FMA) Program
  - o Repetitive Flood Claims (RFC) Program
  - o Severe Repetitive Loss (SRL) Program
- To stay in compliance with DMA2K, the Plan needs to be reviewed and updated every five (5) years.

### **Planning Process**

- Normally, the process would take 18-24 months. However, due to delays in getting the project started and time constraints, it is our hope to have this project completed within 12 months.
- The update of the Regional Plan will include the following components:
  - o Incorporate Amelia County Plan into updated Regional Plan
  - o Update Regional Profile
  - Update Capability Assessment
  - o Update Hazard Identification and Risk Assessment
  - Update Project Data and Maps
  - o Review/Update Mitigation Strategies and Actions
  - Update Plan Maintenance Strategy

### Project Management Team

- The Project Management Team is comprised of one representative from each of the participating localities the Counties of Amelia, Buckingham, Charlotte, Cumberland, Lunenburg, Nottoway, and Prince Edward; and the Town of Farmville.
- Towns (other than Farmville) are represented by their respective county on the Project Management Team.

- The Project Management Team will meet with CRC staff approximately four (4) or five times during the process. In addition, team members will be asked to attend local government meetings in their respective jurisdiction when CRC staff makes presentations to those governing bodies.
- Team members will be asked to review documents and provide feedback. These include, but are not limited to, drafts of the Plan, results of the Hazard Identification and Risk Assessment (HIRA), and other documents.
- Team members will serve as a liaison between the CRC and their respective localities. This includes coordinating with their respective localities to update mitigation strategies and collecting data for inclusion in the Plan.
- The Team will be asked to endorse the final draft of the Plan before it is reviewed by VDEM and FEMA.

### **Project Meetings**

- The Project Management Team will meet an estimated four or five times during the process (subject to change). The group will review materials and provide feedback, and help CRC staff address any issues that may arise during the project.
  - This includes at least two (2) meetings to which regional stakeholders and the public will be invited.

### Public Participation/Comment

- CRC staff will make public presentations to local governing bodies at their regular monthly meetings, to solicit input from governing bodies and the public.
- CRC staff will also make presentations to local civic groups throughout the region (Chambers of Commerce, etc.) during this process.

### WELCOME AND INTRODUCTION

The meeting was called to order at 10:00 a.m. Mr. Fortune gave a brief overview of the project and the process involved, introduced Mr. Coates and Ms. Terry to the group, and passed out materials to the group for discussion of the Hazard Identification and Risk Assessment.

### REVIEW OF HIRA, MATERIALS PRESENTED

Mr. Fortune gave the following handouts to the group:

- Listing of Critical Facilities in the Region

- Selected maps from the State Plan (to show different types of data that could be used from that plan)

The group was given a few minutes to review the handouts, and had the following comments:

- Floods Add the Election Day Flood of 1985, and flooding from Hurricane Camille (1969).
- Winter Storms Add the Ash Wednesday Storm from 1962, and the storms from March 2009. Also, from the Christmas Ice Storm of 1998, there was no power in parts of Lunenburg County for 14 days (people came to Victoria for water and shelter, and the prison provided food for people).
- Thunderstorms Mention power outages from 2010 storm (Southside Electric Cooperative reported ¼ of their system was out, at one point, from that storm). Also, Victoria will provide information on 2000 hail storm.
- Tornadoes There was a downburst in Victoria during the late 1990s.
- Wildfire From the April 2008 fire in Buckingham
   County, no homes were damaged but a significant amount
   of timber was lost. Also, add fires in Lunenburg and
   Nottoway Counties (2001-2002), 2008 fires in multiple
   jurisdictions, and fires throughout the region in April 2007.
- Drought July 2010 was the hottest July on record. Also, is there any way to distinguish between Agricultural and Aquifer drought?
- Earthquake The December 2003 quake was felt in Victoria, and there was damage to some houses there.
- Dam/Levee Failure The hazard rankings for stateregulated dams will change soon. Also, private dams regulated by the Army Corps of Engineers will be required to conform to specs/requirements.

- Man-made hazards There was a haz-mat spill near the Lunenburg/Nottoway County line (Nottoway River) in 2002. Someone emptied a tanker that had been parked overnight for a construction job, spilling tar onto the ground and into the river.
- Critical Facilities Add community health clinics.

There was some discussion on sources of data. Mr. Coates said suggested that, for droughts, CRC staff could check Executive Orders issued by the Governor and might want to check with local offices of the Virginia Department of Health, USDA, or the Virginia Cooperative Extension. He also said he could send CRC staff the link to VDEM situation reports, to help with information for significant hazards of all types.

It was also noted that the Virginia Department of Rail and Public Transportation contacts local officials when a storm hits a locality, to gather information on damages.

### DISCUSSION OF NEXT STEPS, FUTURE WORKSHOPS

Mr. Fortune said he would make changes based on input received from the group and additional data collections, and bring the revised HIRA information back to the group at the next workshop. He also said that the plan is for the group to begin work on updating mitigation actions at the next meeting.

It was decided that the next workshop would be held during the week of November 15. Mr. Fortune said he would try to get materials to the Project Management Team and attendees at the workshop in advance.

### OTHER ISSUES, ADJOURNMENT

There was a brief discussion about public participation. Mr. Fortune said CRC staff planned to make public presentations to local governing bodies later on during the process. In addition, the draft plan, when it is ready, would be made available for public review and comment. There was a brief discussion about whether to distribute public surveys. The consensus was that surveys would not be necessary for the Plan update.

The meeting adjourned at 11:30 a.m.

- Mitigation Strategies There was some discussion on how to proceed. Mr. Coates said that localities should look at available resources – financial and staff – when determining whether to leave strategies in or remove them. He suggested that if a locality has a project "on the shelf," then they might want to add it to the Plan. It was agreed that the group would review the information, and get updates back to CRC staff.

### DISCUSSION OF NEXT STEPS, FUTURE PUBLIC INPUT

There was some discussion about presentations to local governing bodies. It was the consensus of the group that CRC staff should make presentations to local governing bodies once all of the information was updated and the DRAFT plan is ready. 

### WELCOME AND INTRODUCTION, SLIDE PRESENTATION

The meeting was called to order at 5:05 p.m. Mr. Fortune welcomed those in attendance, and explained the purpose of this project – to update the Regional Hazard Mitigation Plan for the seven counties in Planning District 14. The original Plan was completed in late 2005, and has to be updated every five (5) years in order for localities to remain eligible for certain types of FEMA funding.

Amelia County was not part of the original Plan, but is participating in the Plan update. Other changes in the Plan update include: Each participating locality is required to have one mitigation strategy related to compliance with the National Flood Insurance Program; and new and different data sources were being used for the update for various reasons – for instance, the State has acquired new data (which is included in the updated Plan) and localities provided new data. In addition, HAZUS data (which was used in the original Plan) was not used in the update due to compatibility issues with the CRC's operating system.

Mr. Fortune gave a brief slide presentation (see ATTACHMENT #2) that outlined the project and why it was being done (including FEMA requirements) and the process involved in updating the Plan, and showed some of the data that is being updated for the Plan. The presentation also outlined the process for obtaining public input, and a projected timelines of milestones going forward. Mr. Fortune expects the update to be completed by the Fall of 2011.

### QUESTIONS FROM THE PUBLIC

Attendees had some questions about the Plan and the process:

- Someone asked about the acronyms used in the presentation. Mr. Fortune clarified those.
  - o HMP Hazard Mitigation Plan
  - o GIS Geographic Information System (mapping software)
  - o HIRA Hazard Identification and Risk Assessment
  - o FEMA Federal Emergency Management Agency

- o VDEM Virginia Department of Emergency Management
- o PD Planning District
- o PMT Project Management Team
- Mr. Fortune was asked to elaborate on how this plan affects eligibility for FEMA funds. The Plan is a federal requirement. Localities must be covered under a FEMA-approved Hazard Mitigation Plan to be eligible for certain types of FEMA funding, including grant funding for construction/acquisition/demolition projects. The Plan must be reviewed and updated every five years. If this does not happen, a locality could lose eligibility for those funds.
- The mitigation actions related to compliance with the National Flood Insurance Program, would those lead to grants for structural projects? No. Those actions are planning in nature.
- What happens if a locality does not have a plan, and tells FEMA it does not have any money to develop one? Mr. Fortune was not sure, but one person in attendance thought the federal government would take money from another program.
- There was some discussion about the mandate from the federal government on this. The requirement for a Hazard Mitigation Plan is an unfunded mandate. However, Mr. Fortune noted that this update is being funded by a grant from FEMA with participating counties and the Town of Farmville contributing to the non-federal match.

### **Project**

- Review and Update of the Regional Hazard Mitigation Plan for PD 14
- Funded by a Planning Grant from FEMA, plus in-kind from participating localities.
- Required under federal regulations.
  - Disaster Mitigation Act of 2000: requires that localities develop and adopt a Hazard Mitigation Plan to be eligible for certain types of FEMA funding. Plan must be reviewed and updated every five years, per regulations.

Hazard — Act or phenomenon that can potentially result in harm or other unwanted consequences to people or objects

Hazard Mitigation – Steps taken to lessen or reduce the impact of hazards/disasters on people and property by reducing hazard risk and vulnerability Source: FEMA

### **Locality Participation**

- Seven Counties in PD 14 and the Town of Farmville are represented on the Project Management Team
  - PMT working directly with CRC, VDEM staff on updating Plan
- Participation by other towns includes assistance in updating mitigation strategies, reviewing Plan, and adopting Plan.
  - Due to their size, these towns are represented by their respective County on the PMT


### Plan Update Process


- Every section of the Plan is being reviewed and updated.
- Particular emphasis on certain sections of the Plan:
  - Regional Profile
  - Hazard Analysis
  - Vulnerability Assessment
  - Mitigation Strategy

### Process (continued)

What has changed since the original Plan was completed:

- Amelia County part of Plan update
- Different data for Vulnerability Assessment
- New FEMA requirement for plans adopted after October 1, 2008: Localities must have a mitigation action related to compliance with National Flood Insurance Program
- Man-made hazards referenced in update
