## PPTRA RESOLUTION FOR 2009

County of Prince Edward, Virginia

In accordance with the requirements set forth in <u>VA. CODE ANN.</u> §58.1-3524 C.2. and §58.1-3912 E., as amended by Chapter 1 of the Acts of Assembly (2004 Special Session I) and as set forth in *Item 503.E.* (Personal Property Tax Relief Program) of Chapter 951 of the 2005 Acts of Assembly, any qualifying vehicle sitused within the County of Prince Edward, Virginia commencing January 1, 2009, shall receive personal property tax relief in the following manner:

- Personal use vehicles with assessed value of \$1,000 or less will be eligible for 45% tax relief; and
- Personal use vehicles with assessed value of \$1,001 or more shall receive only 45% tax relief on the first \$20,000 in assessed value; and
- All other vehicles which do not meet the definition of "qualifying" (such as business use vehicles, motor homes, etc.) will not be eligible for any form of tax relief under this program; and
- In accordance with Item 503.D.1. of Chapter 951 of the 2005 Acts of Assembly, the entitlement to personal property tax relief for qualifying vehicles for tax year 2005 and all prior tax years shall expire on September 1, 2006. Supplemental assessments for tax years 2005 and prior years that are made on or after September 1, 2006 shall be deemed "non-qualifying" for purposes of state tax relief and the local share due from the taxpayer shall represent 100% of the tax assessable.

Wiley|Wilson is pleased to present the following professional services task order proposal to Prince Edward County, Virginia for Additional Utility PPEA Review services. The additional services consist of Wiley|Wilson serving as the County's engineering and technical resource during the Interim Phase of the Sandy River Reservoir Water Treatment and Distribution Project (PROJECT). For purposes of this proposal, the Interim Phase shall be that part of the PROJECT that begins with the execution of the Interim Agreement between the County and the Design Builder and that ends with either the execution of the anticipated Comprehensive Agreement or the County's termination of the PROJECT. Wiley|Wilson presents this pricing proposal pursuant to our annual services contract with Prince Edward County.

#### Scope of Services

The Scope of Services would include, but not be limited to:

- Serving as the County's engineering and technical resource in assisting the County in fulfilling the County's responsibilities as set forth in Exhibit B to the Interim Agreement.
- Providing the County with an engineering review of the 30% review set of plans and specifications prepared by the Design Builder as set forth in E1.01.A. of Exhibit E to the Interim Agreement.

Summary: The Personnel Committee comprising Supervisors Simpson, Gilfillan, Moore and Wiley met on September 8, 2009 with Sheriff Travis Harris regarding two dispatcher vacancies in the Sheriff's Department. There are a total of six dispatch positions in the Sheriff's Department. The two vacancies were created by a retirement and a resignation. The starting annual, entry-level, starting salary for each position is \$25,040 + benefits. Both positions are partially funded by the Compensation Board and the state has a ninety-day hiring freeze in place. The Sheriff has contacted the Compensation Board and asked for a waiver of the 90-day freeze for one of the positions. The Compensation Board meets on September 16 and will notify the Sheriff on that day of its decision.

Sheriff Harris has requested that the County consider allowing him to fill both positions immediately. The cost of this request would be for the County to fund 100% of both positions during the 90-days of the state hiring freeze. This would represent an estimated cost (or loss of state reimbursement) to the county of about \$6,774 per position for the 90 days.

**Recommendation:** The Committee recommends that the Board authorize the Sheriff to immediately fill one dispatch vacancy and ask the Sheriff to wait until after the decision of the Compensation Board on September 16 to fill the second vacancy.
