At the special meeting of the Board of Supervisors of Prince Edward County, held at the Court House, thereof, on Tuesday, the 22nd day of October, 2020; at 5:30 p.m., there were present:

Chairman Townsend called the special meeting to order.

Supervisor Booth offered the invocation and led the Pledge of Allegiance.

Chairman Townsend stated:

Due to the COVID-19 Emergency, the Board of Supervisors is operating pursuant to and in compliance with its "EMERGENCY ORDINANCE TO EFFECTUATE TEMPORARY CHANGES IN CERTAIN DEADLINES AND TO MODIFY PUBLIC MEETING AND PUBLIC HEARING PRACTICES AND PROCEDURES TO ADDRESS CONTINUITY OF OPERATIONS ASSOCIATED WITH PANDEMIC DISASTER." This meeting is closed to in-person participation by the General Public, but citizens may listen to the meeting by calling 1-844-890-7777, Access Code: 390313.

Chairman Townsend said:

I wish to recognize that Supervisor Robert M. Jones is with us this evening via remote telephone access. As required by the Board of Supervisors' Electronic Meeting Policy and Section 2.2-3708.2 of the Code of

Virginia, Supervisor Jones provided notice that he would have to be physically absent from tonight's Board meeting, because of a previous engagement. He has requested remote participation in tonight's Board meeting from 3286 Poor House Road, Rice, VA. His request is in conformance with the Board's Electronic Meeting Policy and the requirements of the Code of Virginia.

Pending an objection from a member of this Board of Supervisors, Supervisor Jones's participation from his remote location in Rice, Virginia, shall be approved, and shall be recorded in the minutes of this meeting.

There were no objections by the Board of Supervisors members.

In Re: Buildings and Grounds Update

Mr. Ron Van Eps, Buildings and Grounds Director, stated that both he and Jeff Jones would like to apologize to the Board of Supervisors and the citizens of the Prince Edward County for the reduction of services at the recycling sites. He said the County was without trucks for about two weeks; in addition, one driver suffered a health emergency on Monday. This individual spent time in the hospital but has been released; he is in good spirits and is doing well, but we are not sure if or when he will return to work.

Mr. Van Eps said the County has received the International truck back [from the mechanic] and it is in operation. The new driver, Daniel Townsend, will be starting work Monday, October 26.

Mr. Van Eps reported a lot of the sites have been caught up; he said the only remaining issues are the tire bins and cardboard bins at Green Bay and Darlington Heights sites. He said all the plastic has been caught up, the cardboard is empty at the other sites, the trash bins were empty as of earlier today and another sweep will be done tomorrow to make sure it is clear for the weekend. He hopes to get a few of the bins at Green Bay and Darlington Heights [emptied] as well.

Mr. Van Eps stated two applicants are being reviewed for a position for the Heavy Machine Operators at the landfill, and possibly a third. He said the first review of those applications is November 2, 2020.

Mr. Van Eps then stated an employee at the Prospect site had been turning people away because every bin there was overfilled. He said he has given this individual some direction if this situation happens again.

Mrs. Puckett commended Mr. Van Eps and Mr. Jeff Jones; the whole team has put in an extraordinary effort this week; Mr. Van Eps has been driving the trash truck all week, working with his men. She said all of them, including those at the landfill, have put in extra hours to bring everything back in line to the satisfaction that the Board would expect. She said while these situations were completely beyond their control, they were taking personal responsibility for getting it back to standards. Mrs. Puckett personally thanked them and congratulated them for a job well done, and for understanding the urgency of getting the sites back to the standard that the Board of Supervisors and citizens have come to expect. She said Mr. Van Eps and his staff deserve our appreciation for the job they have done this week.

Mr. Van Eps said when the truck driver was having his health emergency, a co-worker was very adamant that he go to the hospital; when they arrived at the hospital, the hospital staff stated if he would have stayed at the landfill another ten minutes, his outcome could have been much worse.

Chairman Townsend asked if one of the trucks breaks down in the future, would the County be able to lease a truck. Mr. Van Eps said that he tried to do so in the past, but they are difficult to locate; he said there only two hook-lift trucks in the state of Virginia that could be purchased and none that could be rent or lease. Mr. Van Eps said the hook-lift truck is not the most popular truck, but is far better for our drivers because they are not required to throw a very heavy cable around the bins, and can normally do most of it from within the cab. He said their health and well-being is why he chose that type of truck initially and stays with it.
