Award of Contract for Via Sacra (VDOT Revenue Sharing Project)

Summary: As the Board will recall, the County was awarded \$481,559 of VDOT Revenue Sharing Funds to assist Hampden-Sydney College with the upgrade of 0.13 miles of Via Sacra (Route 1001). Construction bids were received on the project on Friday and are attached. The apparent low bid of \$380,108 by WCW Earthworks has been reviewed and is recommended by Draper Aden Associates, the project engineers. Hampden-Sydney College, which is providing the matching funds, is in agreement with Draper Aden's recommendation.

As the County is the fiscal agent for the project and is the recipient of the VDOT funds, the Board must authorize the award of the contract. The College would like to have the contractor start construction on the project the day after graduation, which is Monday, May 12.

Note: There is no County funding in this project. Hampden-Sydney is providing the local matching funding for the VDOT Revenue Sharing Funds.
