Being there was a quorum present at the appointed hour the meeting was called to order by Mr. Showalter, Chairman of the IDA.

In recognition of 20 years of dedicated service to the IDA, Mr. Showalter presented to Mr. David Stables, whose term expires June 30, 2008, a special hand carved writing pen made from cut over walnut harvested in Prince Edward County. In addition, Mr. Jim Wilck, a new 2009 Authority member whose term takes effect July 1, 2008, was introduced to the existing members of the Authority.

Mr. Showalter presented the November 30, 2007 minutes for approval. After the Board had a chance to review on a motion made by Virginia Price and seconded by Tony Williams, it was recommended to accept the IDA Minutes from the November 30, 2007 meeting as presented. The motion was accepted by the following vote.

\*\$57,794 is a committed obligation to Hurt & Profitt Engineering for the development of the three ready-to-go industrial sites at the Prince Edward Business Park.

Mr. Showalter asked Sharon to go over the recent action by the Prince Edward Board of Supervisors to convey 37 +/- acres from the County to the IDA for development of three "ready-to-go" industrial sites. Sharon explained that at the May 13, 2008 Board of Supervisors Meeting, the Board approved the conveyance of 37 +/- acres at the Prince Edward Business Park to the Prince Edward County IDA from the County. This will allow the IDA to move forward with the timely development of three "ready-to-go" industrial sites at the Business Park. The IDA Board now needs to accept the conveyance and proceed with the deed transfer.

On a motion made by L. D. Phaup and seconded by Tony Williams, it was recommended to accept the conveyance of 37+/- acres from Prince Edward County for the development of three "ready-to-go" industrial sites at the Business Park. The motion was accepted by the following vote.

Sharon then went on to explain that during the transfer of 39 +/- acres of land for commercial development from Prince Edward County to the IDA in May 2006, a small piece of land consisting of 1.69 acres was inadvertently omitted, therefore now needing a "deed of correction" to correct the omission. Preston Lancaster, the IDA Attorney then explained that both property conveyances could be done at the same time without needing to do two separate deeds.

On a motion made by Virginia Price and seconded by L. D. Phaup, it was recommended to authorize Preston Lancaster to prepare the necessary deed documents to accept the 37+/- acres from Prince Edward County for the development of three "ready-to-go" industrial sites at the Business Park and to correct the

omission of 1.69 acres, in addition to authorizing Bobby Showalter to sign all the necessary documents. The motion was accepted by the following vote.

Mr. Showalter then asked Sharon for an update on the hiring of an engineering firm to assist with the development of three "ready-to-go" industrial sites at the Prince Edward Business Park.

Sharon started by reminding the Authority members that at the November 30, 2007 meeting the IDA authorized the Chairman to proceed with the hiring of an engineering firm to assist with the development of three "ready-to-go" industrial sites at the Prince Edward Business Park. Since then in March, 2008 proposals were received from Draper Aden, Wiley & Wilson, Hurt & Profitt and Dewberry (See chart below). As a result the Chairman accepted the proposal from Hurt & Profitt for \$57,794.00.

Currently Hurt & Profitt is actively working on the project designs. Hopefully grading of the sites can begin in August of 2008. In addition, Prince Edward County received an Economic Development Tobacco Commission Grant in the amount of \$193,510 to assist with the costs associated with the development of the industrial sites in the estimated amount of \$762,000.
