Mr. Showalter then asked Sharon to go over the August 6, 2013 Sales Contract Termination Letter received from Robert D. Fowler, Manager for Prince Edward Development LLC., cancelling the Purchase Contract for 94+/- acres to construct the Granite Falls Inn/Conference Center and Workforce Training Center.

Sharon stated that the letter was e-mailed to her as the IDA Secretary on August 6, 2013 at approximately 10:17 am. Mr. Fowler's letter states inability to "obtain sufficient New Market Tax Credit allocation from the current round to begin construction of the Granite Falls Project." The acceptance of the Termination of the Sales Contract will also immediately terminate the grant agreement. This information was presented to the Board of Supervisors as a signature on the Grant Agreement and for the Board of Supervisors records at the July 13, 2013 Board Meeting.

It is the IDA's responsibility to make the formal acceptance of the Termination Letter since the Sales Contract was between the Prince Edward Industrial Development Authority and Prince Edward Development, LLC. This will also initiate the return of the \$75,000 security deposit to Prince Edward Development, LLC. After a careful search, no outstanding items or bills were found owing against this project. Therefore, there should be no reason to withhold funds from the full security deposit refund. The amount of the security deposit is \$75,000.

Sharon suggested that the IDA termination acceptance be broken down into 3 motions with a roll call vote to be taken for each one. This is to make sure the IDA records are perfectly clear and with no interpretation confusion in the future.

It appears we won't be successful in obtaining sufficient New Market Tax Credit allocation from the current round to begin construction of the Granite Falls Project. Since the Project can't be financed

without NMTCs and the next opportunity for allocation doesn't occur until after expiration of the Contract, pursuant to Section 13(g) we are terminating the Real Estate Contract originally dated July 21, 2009, effective immediately.

We have not abandoned the Project and will seek an allocation of NMTCs in the next round expected to be awarded in April of 2014. If successful, we will be back in contact with you to see if the Property is still available.

Please express my sincere appreciation to the individual Authority board members for their years of patience and support as we endeavor to bring this project to fruition.
