Mr. Showalter asked if there were any comments or questions regarding the Robinson, Farmer, Cox Associates IDA Financial Report for June 30, 2014. Gwen Eddleman entered the meeting at this time.

Mr. Showalter then asked the County Administrator, Wade Bartlett, to give a presentation regarding a financing request by the Poplar Hill Community Development Authority (CDA). Mr. Bartlett stated that in an effort to move off center and encourage development at the Manor area, the CDA is asking for the IDA's assistance in paying off several lien holders with claims against the CDA in an amount equal to \$200,000. The liens are placed on the properties around the Manor Golf Course, and not the Golf Course itself. A settlement with the litigants of approximately 10 cents on the dollar and has been brokered by the County Attorney Jim Ennis. Revenue derived from the CDA's ability to levy special taxes at the Manor will be the proposed as source of repayment to the IDA. A draft Resolution authorizing the IDA's approval of such a loan was presented by Mr. Bartlett.

After some discussion focusing on paragraph #7's wording listing the lienholders and their respective amounts owed, a motion was made by Tim Tharpe to conditionally approve the Resolution subject to Mr. Tinnell, the IDA Attorney and Mr. Ennis making the suggested changes to paragraph #7 listing the
