At 12:14 pm, there being a quorum present, Mr. Showalter welcomed everyone and called the June 28, 2016 IDA Meeting to order.

Mr. Showalter then opened the Public Hearing regarding the IDA of Prince Edward County issuance of a \$9,900,000 Bond for the benefit of Ferrum College in Franklin County, Virginia. Mr. Bobby Thompson, representing Ferrum College, thanked the IDA of Prince Edward County for considering the Bond request for Ferrum. There being no one else wishing to speak, Mr. Showalter closed the Public Hearing.

Mr. Al Knighton, from Wood Rogers, reviewed the Resolution authorizing the issuance of a \$9.9 million financing for Ferrum College and explained that there would be no cost to Prince Edward County or the IDA. Mr. James Anderson, from Davenport and Company, explained why there was a request for Prince Edward IDA to issue the Bond, and as per state code there is no liability to the IDA. It must also be stated in the motion to approve Bobby Showalter, as the IDA Chair, to sign any and all necessary documents associated with the issuance of the Bond.

James Moore made a motion to approve the Resolution and authorize Mr. Showalter to sign all the necessary documents. The motion was seconded by Edgar Jones. The motion was approved by the following vote:

Mr. Knighton then explained that the Resolution of Authority approves the Bond documents; authorizes the Chair or Vice Chair of the IDA to execute the agreement; to assign the Note to the Bondholder, etc.; and designates the Bond as a qualified tax-exempt obligation.

The addition of this equipment to Paris Ceramics fabrication processes enabled Paris to add an additional full time employee and cross train another.

• Draw #1 of loan to W. C. Newman Concrete in the amount of \$100,000 was disbursed on May 2, 2016. There is a remaining balance of \$80,000 available.
