The CPMT Meeting for August 18, 2022 began at 9:40 am. A motion was made by Erica Hazelwood to approve the meeting minutes from July, 2022 with no changes. Karen Townsend seconded the motion. All other members approved the minutes as well.

# Standing Agenda Items:

- a. Funding Information: Members briefed on current state of funds for current fiscal year (see attached).
- b. Collection of Parental Contributions: Received one parental contribution payment this month.
