The Canvass Meeting was called to order by Mr. Charles Puckett, Chairman at 8:35 am on June 21,2023. No Provisional Ballots were received.

The next order of business was to review all votes called to the General Registrar on the night of the election. After reviewing each precinct, all locations were accounted for and there were no discrepancies between what was placed on the website and called in the night of the election during our Canvass. It was noted that the Board was proud of our Poll Workers as they had a very challenging 45-day Early Voting with 80 voters who took advantage of the early voting. There were nine precincts reporting a total 274 voters.

After reviewing the numbers from all 9 Precincts, we moved on to the CAP for Early Voting in Person, Early Voting by Mail and Absentee Ballots. All information reported from this precinct was correct.

We, The Electoral Board adjourned on Wednesday, June 21st at 10:30 am, as all secure packages from the June Primary were delivered to the Clerk of Circuit Court with signatures received as required. The Electoral Board will reconvene on Friday, June 23,2023 at 12 Noon to finalize processing the June 2023 Republican Primary Election.

Central Absentee Processing (CAP) numbers were updated as there was only two ballots received. One ballot was by email and one was returned unopened. After review of this information, updates to the Website. The final total for this primary was 275. All signatures were affixed to documents which were signed, sealed, and transferred as required by State Law to the Office of Clerk of Circuit Court. The Electoral Board meeting was adjourned at 12:41 pm.
