At the regular meeting of the Board of Supervisors of Prince Edward County, held at the Court House,

thereof, on Tuesday, the 12<sup>th</sup> day of February, 2019; at 7:00 p.m., there were present:

Chairman Wilck called the regular meeting to order. Supervisor Townsend offered the invocation and led the Pledge of Allegiance.

In Re: Public Participation

Daniel Jordan, Director, High Bridge Trail State Park, introduced Veronica Flick, Director of Twin

Lakes State Park. He then presented an informational brochure that will be distributed to promote the State

Parks. He reviewed statistics and said that they are hoping for a better season this year; the weather caused

a 22% decline in revenue and a 7% decline in attendance in 2018.

Veronica Flick said the brochures also provide park history, statistics, opportunities and challenges.

She said the annual revenue for 2018 was \$443,000 and the annual attendance was 137,000.

Mr. Jordan said there were several culvert collapses in Cumberland and Prince Edward Counties, at

a cost of approximately \$1 million in damage; these repairs are being scheduled and should be complete in

approximately a month or two. He said a 2,500-square foot Visitors Center will be built at Camp Paradise,

in Rice, and will resemble a train station and will also include administrative offices. Mr. Jordan said the General Assembly is meeting, and Delegate Wright is working to get High Bridge Trail listed on the C25 Form, which allows [State] Parks to accept and to buy land. All of High Bridge Trail has now been accepted into the amendment. He said the Jeter Cemetery, in Camp Paradise, with 67 graves but only one marked, that of Mr. Jeter who was hit by a train in 1906, is being restored. He said they are working in conjunction with Longwood University on that project. He stated VA Tech Landscape/Architectural students have designed a conceptual plan and the new students this spring will take the concept and put actual plans to it. He then said all requirements have been met for the Pamplin extension; once Norfolk Southern sends the Sale Offer letter to Richmond, once that is approved, they will build a mile of trail into Pamplin and then Norfolk Southern will abandon additional rail lines and allow the Trail to continue into Burkeville.

Supervisor Southall asked if there is a highway that goes over Natural Bridge; Ms. Flick said VDOT recommended that it be removed but it is not closed yet.

Carol Broadwater, Prince Edward Volunteer Rescue Squad, stated as was presented in a previous meeting, the Prince Edward Rescue Squad has immediate needs in order to continue to serve County residents. She said there is a need to purchase an ambulance this year and next year; she said if an order is placed now, it will take nine months to receive the ambulance. She said they will need to know by March 15 if funding is approved for an ambulance so they may order one. Mrs. Broadwater said they also need an Executive Director to run the business and funding to fill the position. She said there is a need for \$300,000 in additional funding. Discussion followed on the cost of an ambulance with all necessary equipment. Chris McKay stated all equipment from the older ambulance would be moved to the new ambulance, saving the cost difference, and reviewed the type of equipment necessary.

Supervisor Wilck requested information on how much time would be saved with a ramp connecting Route 460 and Third Street.

Haley Hobbs, Longwood University Student, presented information on Child Abuse Awareness program and asked for the Board's consideration of a proclamation to make April "Child Abuse Awareness" Month in Prince Edward County. She presented statistics on child abuse nationwide and in Prince Edward County.

Professor Ian Danielson stated his class collected several strongly-worded proclamations from national non-profits and advocacy groups, and asked if the Board would like to be collaborative in selecting

the language that should be used in a proclamation. He said the class could draft a sample proclamation for consideration.

Lacie Ellithorpe, Longwood University Student, presented further information on the Child Abuse Awareness proclamation, and asked for permission to put on several training and information sessions and will be held at no cost to inform and promote child abuse awareness in the County. She said these events will be held at the library and other meeting spaces and will be available to everyone in the County.

Chairman Wilck stated due to the resignation of Supervisor Timmons, we have a vacancy on the Board of Supervisors. He said there are three applicants to consider; it is time to vote in the order they were interviewed.

#### In Re: Highway Matters

Ms. Carrie Shepheard, Acting Resident Engineer, VDOT, Farmville Residency, presented the maintenance update: she said crews have repaired severe erosion to a cross-over on Route 460 just west of the Route 15 exit; crews machined and added stone to all gravel roads. She said that in the coming weeks, VDOT will be performing maintenance on shoulders on Route 360 and on Route 617, which is the detour for Route 600, and revisit Darlington Heights Road for secondary mowing. She said work will be completed on the inlet end of the pipe on Route 613 with an estimated reopening in mid-March. She then said for the

Route 600 bridge, crews will be installing steel beams around the end of February and will replace the deck and estimate it will be reopened the beginning of April. She said a bridge replacement is scheduled to go to advertisement in April and construction should begin in the fall of 2019 for Route 622 over the Norfolk Southern Railroad.

Supervisor Townsend asked the status of the chevrons that are to be placed on Leigh Mountain Road. He said the barrels have been placed on Mills Creek.

Supervisor Emert said he has been contacted by several citizens asking why VDOT pushed the debris from the storm to their property when it clearly did not come from their property. He said there are several places along Pin Oak Road where this has occurred. Ms. Shepheard said the intention is to clean the debris out of the right of way; there is a location where it is being stockpiled. She will look into the issue.

Supervisor Pride thanked Ms. Shepheard for her response to attend her March Town Hall meeting.

Supervisor Southall said trees were blown down on Price Drive but VDOT got them cleaned up quickly.

Supervisor Townsend said that nothing has been done yet along Moore's Ordinary Road and Route 360 eastbound at the drop-off.

#### In Re: Resolution - U.S. 460 Interchange (East Third Street)

Chairman Wilck stated the Board is appealing a VDOT ruling to the Commonwealth Transportation Board for the Third Street Interchange. He is asking for support for a resolution calling for VDOT to recognize the importance of completing the Third Street Interchange and to provide the necessary funding to complete this Interchange. He asked the Board to pass this resolution to show the full Board supports his efforts to have this Interchange completed; the Town of Farmville has been asked to provide a similar resolution.

Supervisor Cooper-Jones made a motion, seconded by Supervisor Jones, to approve the Resolution in support of Improvements to the US 460 East Interchange and authorize the Board Chair to execute the Resolution; the motion carried:

# A Resolution of the Board of Supervisors of the County of Prince Edward, Virginia

#### Improvements to the US 460 East Interchange

**WHEREAS**, in June 2005, the County of Prince Edward jointly participated in a Feasibility Study with the Town of Farmville to develop recommendations for the completion of the Farmville US 460 East Interchange; and

**WHEREAS**, the Feasibility Study was in part funded by VDOT's Rural Transportation Planning Grant Program through the Piedmont Planning District Commission; and

**WHEREAS**, the study concluded "...the economic development opportunities for the eastern route 460 Business corridor were severely limited due to the lack of access to westbound 460"; and

**WHEREAS**, US 460 is identified in VTRANS 2040 Multimodal Transportation plan as a Corridor of Statewide Significance that traverses the Commonwealth from Beckley, West Virginia to Hampton Roads, Virginia; and

**WHEREAS**, the current interchange does not provide westbound access from Business 460 to U.S. 460 or eastbound access from U.S. 460 to Business 460; and

**WHEREAS**, this limited access has negatively impacted the development of a major commercial corridor in the Town of Farmville; and

**WHEREAS**, the limited access forces heavy trucks to travel through residential communities or through the middle of the Town of Farmville on a two-lane road; and

**WHEREAS**, this route forces these trucks to cross pedestrian crosswalks used by students of Longwood University to traverse from their Dorm rooms to their classrooms, the Library and Cafeteria, thereby jeopardizing their safety; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of Supervisors of the County of Prince Edward hereby supports the completion of the Interchange and urges the Virginia Department of Transportation to recognize the need and provide the necessary funding to complete this Interchange.

# In Re: Shentel Cable Television Franchise Renewal

Mr. Bartlett said Shenandoah Cable Television, LLC, doing business as Shentel, is requesting to renew the existing Franchise Agreement which was originally adopted in 1993. The Franchise Agreement was last renewed in June of 2010, effective in December 2008.

Per Section 15.2-2108.21 of the *Code of Virginia* such agreements shall have a term of 15 years. Section 15.2-2018.1.1.C of the *Code of Virginia* states "...no new or renewed cable franchise entered into on or after January 1, 2007 shall include a franchise fee as long as cable services are subject to the Virginia Communications Sales and Use Tax." Shentel is subject to this tax which is capped at 5% per Chapter 6.2 of Title 58.1 of the *Code of Virginia*.

Shentel pays this tax directly to the Commonwealth. The Commonwealth then remits to the County our portion as part of the Telecommunication Tax we receive each month.

With deregulation, franchise agreements no longer provide exclusive monopolies to cable companies. As stated in the heading, this is a non-exclusive franchise meaning any other provider could enter the market if they so wished. No longer having the authority to negotiate the franchise fee, the primary purpose of the franchise agreement is to reach agreement on the use of public rights of way, and to require Shentel to indemnify the County for any work done in the rights of way.

Supervisor Jones made a motion, seconded by Supervisor Emert, to approve the Resolution Approving the Renewal of the Cable Television Franchise.

Supervisor Cooper-Jones stated she does not see why the bill for their service keeps escalating with nothing new or of increased value; she asked why they are the only cable company in the County. She then stated Verizon and AT&T both have offices in town and asked why they don't offer services; she said she is interested in others coming to the area. Discussion followed regarding the quality and high bill for cable and internet services in the area.

Mr. Bartlett said the franchise agreement is required by the FCC even though there are no rights of way applicable to Prince Edward County.

The Board determined that it would be beneficial to have a spokesperson from Shentel attend a meeting and tabled action on the issue. Supervisor Jones rescinded his motion.

# A Resolution of the Board of Supervisors of the County of Prince Edward, Virginia

### APPROVING THE RENEWAL OF THE CABLE TELEVISION FRANCHISE

**WHEREAS**, Shenandoah Cable Television, LLC ("Franchisee") owns, operates and maintains a cable television system ("System") serving Prince Edward County, Virginia pursuant to a franchise agreement which expired on December 13, 2018 (the "Franchise") issued by Prince Edward County, Virginia (the "Franchise Authority"), and Franchisee is the duly authorized holder of the Franchise; and

**WHEREAS**, Franchisee and Franchise Authority have continued to follow and be bound by the Franchise; and

**WHEREAS**, Franchisee has requested the consent of the Franchise Authority for the renewal of the Franchise in accordance with the requirements of the Franchise and applicable law; and

**WHEREAS**, Franchisee has represented that it will comply with the terms and conditions of the Franchise; and

**WHEREAS**, the Franchise Authority believes that it is in the best interest of the community to approve the renewal of the Franchise granted to Franchisee.

# NOW, THEREFORE, BE IT RESOLVED BY THE FRANCHISE AUTHORITY AS FOLLOWS:

**SECTION 1:** The Franchise Authority hereby approves and consents to the renewal for a term of ten years of the Franchise, all in accordance with the terms of the Franchise and applicable law and Franchisee shall comply with the terms and conditions of the Franchise.

**SECTION 2**: The Franchise Authority confirms that the renewal term of the Franchise shall be for a term of fifteen (15) years deemed to have commenced on December 14, 2018 and ending on December 13, 2033.

**SECTION 3:** The Franchise Authority agrees that the pledge of, or grant of a security interest in, the Franchise to any lender(s) of Shenandoah Cable Television, LLC or its affiliates, for the purpose of securing indebtedness, shall not require the consent of Franchise Authority and is hereby authorized.

**SECTION 4**: This Resolution shall have the force of a continuing agreement with Franchisee, and Franchising Authority shall not revoke, amend or otherwise alter this Resolution without the consent of Franchisee.

### <u>In Re: STEPS – Virginia Homeless Solutions Program (VHSP)</u>

Mr. Bartlett stated that since April 2013, the Prince Edward County Board of Supervisors has approved STEPS request to act on behalf of Prince Edward County in the execution of the Virginia Homeless Solutions Program (VHSP). The VHSP provides the following services: rapid rehousing, prevention and shelter services to those who qualify. Funding for these services is received through a grant from the Virginia Department of Housing and Community Development (DHCD). STEPS serves as the lead agency, coordinating homeless services across our region, for the Heartland Local Planning Group, in an attempt to enhance and not duplicate services.

Mr. Bartlett said there is no request for matching funds from the County and we have not provided any funds for the duration of this program. The VHSP grant application is due March 30, 2019.

Supervisor Townsend made a motion, seconded by Supervisor Cooper-Jones, to authorize STEPS to continue to act on behalf of Prince Edward County in the provision of emergency housing services to our

citizens and authorize the County Administrator to sign the certification form and any other required documents; the motion carried:

# In Re: Properties Committee Report

Mr. Bartlett said that on January 24, 2019, the Board of Supervisors accepted the proposal from Blair Construction for the construction of the new building for Social Services and STEPS upon the acceptance of various value engineering proposals being accepted to arrive at a final price. The Properties Committee met with the Architect, General Contractor and the Electrical Subcontractor on January 30, 2019.

The Committee reviewed various Value Engineering (VE) proposals. The Committee recommends the following VE proposals be accepted for the new Social Services/STEPS building: Additional savings may be available after further research and consultation with YAKATTACK.

- 1. Tempered glass vice bulletproof glass at transaction windows Savings = \$30,000 min.
- 2. Delete High Density Storage and thickened concrete Savings = \$56,000
- 3. Run power and phone overhead vice underground Savings = \$25,000
- 4. Change Emetco 22-gauge roof to 24-gauge VR-16 Architectural Panel & Nucor Classic Wall Panels
   Savings = \$115,000
- 5. Substitute untreated trusses, etc., with sprinkler system for Fire Treated Savings = \$50,000

# TOTAL SAVINGS = \$276,000

The Committee recommends the following VE proposals be accepted for the STEPS CENTRE:

- 1. Allow set screw steel fitting for all EMT regardless of size Savings = \$2,400
- 2. Allow MC cable throughout the building where allowed by code Savings = \$7,500
- 3. Change copper feeder wire to aluminum conductors Savings = \$21,000
- 4. Install Fire Alarm cable in open air less conduit Savings = \$5,500
- 5. Remove NETA testing and allow CEC to perform testing Savings = \$7,000
- 6. Remove lighting relay panels, add occupancy sensors built into the fixtures on manufacturing floor, if YAKATTACK approves Savings \$6,800

TOTAL SAVINGS = \$50,200
