The CPMT Meeting for December 14, 2023, began at 10:07 am. Cyntina Bagley, with a second from Jena Fowlkes recommended approval of the minutes of the November 2023 minutes. All other members approved of the minutes as well.

Standing Agenda Items:

- a. Funding Information: CSA Coordinator provided funding information to all members; attached. We have received funding information for FY24. Based on current encumbrances, the County will have to submit a supplement for FY24.
- b. Collection of Parental Contributions: Based on the new requirements for parental co-payment, we do not currently have any parents responsible for a co-payment.
- c. Utilization Management: No discussion on Utilization Management this month.
- d. Long Range Planning/Measurable Performance: Joint meeting with the FAPT and CPMT teams on January 11, 2024, would be a good way to conduct a training day and, also for the different team members to understand what each agency does and how the agency contributes to the teams. Each agency would have a presentation of about 15 minutes with a 15- minute period for questions, if there are any. The location for the joint meeting will be the train station. Closed Session:

CPMT will discuss this issue further at the January 2024 meeting.
