# In Re: Courthouse Renovation Project Update

Mr. Josh Bower, AIA, Crabtree, Rohrbaugh & Associates Architects, presented a project update to the Board of Supervisors.

Mr. Bower discussed the plans to renovate and fit-out the STEPS building; he said Social Services currently occupies 8,000 square feet in the Courthouse and their space in the STEPS building will increase to 11,250 square feet. He reviewed plans delineating the office space for both Social Services and the STEPS program and offices.

Supervisor Timmons said the design meets the design requests of the STEPS Board, and Roma Morris. Director of Social Services.

Mr. Bower then reviewed the plans for renovations for the Juvenile Court, General District Court, the Clerk of Courts and the Magistrate. He said there is a deadline of December 31 [2018] for the General District Court and Juvenile Courts. He said there will be a secure entrance and upgrades for the Sheriff's Department. Improvements will be done on the second floor, to include the Commonwealth Attorney's office, and some renovations will be done on the third floor in the main courtroom; this should go to bid in June or July [2018].

Supervisor Timmons stated the judges, magistrate, and Juvenile Probation have all given their approval; he said the Committee recommends moving forward with the renovations.

Supervisor Jones said the Committee has done a good job getting the project organized.

### In Re: Highway Matters

Supervisor Emert reported there is trash on Route 608, Prospect Road, and on Hard Times Road coming out of the landfill, several citizens have reported mud and trash is being brought out by the trucks and scattered on the road all the way to Route 460. He asked if the County has a sweeper brush to help with the mud cleanup; Mr. Bartlett said we do not.

Supervisor Pride stated there is excessive trash on Abilene Road, Route 133.

Supervisor Townsend said there is trash and debris all over the district. He stated chevrons are needed on a curve; he will email the address to Mr. Bartlett.

Supervisor Jones said there are potholes throughout his district, and county-wide, from the cold weather. He said VDOT just needs to drive the roads.

Supervisor Timmons stated the sign is down at the Spring Creek Road and Darlington Heights Road intersection. He asked if someone was able to get to Nursery Road.

Supervisor Townsend said there is logging on Oak Grove Road, off Redd Shop Road. Mr. Bartlett said they have already been warned about the mud.

Supervisor Pride said there is a rut along the side of intersection of Route 671 (County Line Road) and Route 15.

#### In Re: Public Hearing – Special Use Permit, Abner King

Chairman Cooper-Jones announced that this was the date and time scheduled for a public hearing on the request from Abner King for a Special Use Permit to permit a Custom Manufacturing operation within an existing building located at 653 Plum Creek Road on Tax Map Parcel 008-A-20, owned by Abner and Rebecca King. The property is zoned A1, Agricultural Conservation and this zoning classification permits Custom Manufacturing by Special Use Permit. Notice of this hearing was advertised according to law in the Friday, February 2, 2018, and Friday, February 9, 2018 editions of THE FARMVILLE HERALD, a newspaper published in the County of Prince Edward.

Chairman Cooper-Jones opened the public hearing.

Nate Boehmer spoke in support of Abner King. Mr. Boehmer stated he owned the farm prior to Mr. King buying it; Mr. King is family-driven and wishes to work at home.

There being no one further wishing to speak, Chairman Cooper-Jones closed the public hearing.

Mr. Bartlett stated the property is approximately 55 acres. No exterior improvements are planned, and the location has ample parking on-site. Mr. King will be custom manufacturing storage sheds/buildings for a third-party vendor and will operate within an existing 2,400 square foot building and may employ up to six people.

The Planning Commission conducted a public hearing on December 19, 2017 to obtain public comment on the proposed Special Use Permit. Three citizens spoke concerning traffic, safety, noise and the location of the building. The Planning Commission postponed the matter to gather more information from the applicant concerning the issues raised during the meeting.

The Planning Commission continued discussion on the request during its January 16, 2018 meeting and recommended forwarding the application to the Board of Supervisors for approval with the following conditions:

- No retail sales on site
- Maximum of 15 finished buildings stored on-site
- Fence/buffer around generator for noise control
- Shrubs planted to continue the buffer from its existing location to the barn
- Portable toilet facilities maintained for employees

Staff has no concerns of negative impacts on the surrounding properties associated with the request.

Supervisor Jones stated the vote was postponed during the first date of the public hearing in order for Mr. King to come to the meeting; he has agreed to take care of the concerns that the Planning Commission had.

Mr. Bartlett stated the nearest home is 400 feet away. Mr. King has agreed to comply with the conditions.

Supervisor Timmons asked if the roads and bridges are substantial enough to handle the truck traffic.

Mr. Bartlett said VDOT has given its approval; he added the same trucks and hauling of sheds was done by
the prior owner. Mr. Bartlett added the sheds weigh less than loaded cattle trailers.

Supervisor Timmons stated that in the area in which he lives, in the Darlington Heights area, Amish families have a sawmill about three-quarters of a mile from his home, and another has been built about three-tenths of a mile from his home. He said there is noise from a generator running from 6:30 a.m. until dark; in addition, a large loader is running that doesn't seem to have a muffler on it. He said it is not fair for a group to come in and use their property which infringes on the property and rights of others. He said the sawmills are an eyesore to its neighbors, and asked how the noise from the generators can be managed.

Supervisor Timmons then asked the process if Mr. King seeks to increase production next year. Mr. Bartlett stated that if Mr. King wishes to expand his operations or the building, he would have to return to the County for another Special Use Permit and public hearing.

Chairman Cooper-Jones said the hours are proposed to be from 7:00 a.m. until 5:00 p.m., no weekends, and three to five employees.

Supervisor Timmons asked how it will be monitored. Mr. Bartlett said enforcement is complaint based, as are all ordinances. He said if the neighbors complain, it will be checked out. If he expands his business without an updated Special Use Permit, the County can cease his operations.

Supervisor Townsend made a motion, seconded by Supervisor Pride, to approve the Special Use Permit Application from Abner King to permit a Custom Manufacturing operation within an existing building located at 653 Plum Creek Road on Tax Map Parcel 008-A-20, with the following conditions:

Chairman Cooper-Jones announced that this was the date and time scheduled for a public hearing

on the request from Bart Gray for a Special Use Permit to operate an Indoor/Outdoor Commercial Sports and

Recreation Center located at 140 Sheppards Road on property identified as Tax Map Parcel 022-A-73. This

is an A2, Agricultural Residential District. Notice of this hearing was advertised according to law in the

Friday, February 2, 2018, and Friday, February 9, 2018 editions of THE FARMVILLE HERALD, a

newspaper published in the County of Prince Edward.

The property is approximately 27 acres and the proposed facility will consist of an approximately

7,000 square foot building that will house two batting cages, a synthetic field space, and off-street parking.

The facility will operate Monday through Sunday, 12:00 p.m. - 10:00 p.m. with limited openings outside of

the normal operating hours for special occasions.

The Planning Commission conducted a public hearing on January 16, 2018 to obtain public

comment of the proposed Special Use Permit. One person spoke to the application concerning the safety of

operating the facility adjacent to the existing sawmill operations of Lindsay Hardwoods.

The Planning Commission recommended forwarding the application to the Board of Supervisors

for approval with the following conditions:

o A seven-foot high fence be installed in advance of the building opening, along the Southern edge of

the parking lot and attached to the building.

o Future outside pitching mounds on the north side must be fenced.

O Any future expansion of the operation must obtain another Special Use Permit and approval.

Staff does not have any concerns of negative impacts on the surrounding properties associated with the request.

Chairman Cooper-Jones opened the public hearing.

Bart Gray presented photographs to the Board members and said he was not pursuing the outdoor field portion of the project. He said he gave Mr. Fowler further information to provide to the Board members.

Supervisor Timmons asked for clarification on the hours proposed for the Center. Mr. Gray said hours will be from 11:00 a.m. until 10:30 p.m. on weekdays, 9:00 a.m. until 10:30 p.m. on Saturday, and 12:00 noon – 9:00 p.m. on Sunday.

Supervisor Timmons asked how many cars will be on the property at any one time. Mr. Gray said they expect two youth baseball teams, with nine cars per team, and the coaches, would total about 20 cars. He said they would stagger the times to help alleviate traffic congestion.

Supervisor Timmons asked if the entire operation is to be held inside. Mr. Gray said it is; he said if anything is to be done outside behind the center, he is aware he needs to return to the County for an additional public hearing. He said there are doors along the north side that may be opened for light and air and that side of the building will be fenced. Mr. Gray said fencing was not in the original plan but has no problem installing it. He added the seven-foot-high fence is not standard, but is security fencing and is about \$1,000 more than normal six-foot-high fencing.

Supervisor Timmons said the sawmill has no fencing, even from the residential area or the Executive Inn.

Mr. Gray said he thought people would park and go into the building; this is not an unsupervised operation. He said there are coaches coming in with their teams. It is a 7,000 square foot clear span building with two batting cages and enough room to throw and hit ground balls.

Mr. Bartlett said the Planning Commission felt that a compromise may be approved by the Board of Supervisors, of extending the wooden fence on the southeast edge, with it connecting to the building.

Supervisor Timmons asked about the north side if the doors are opened. Mr. Gray said he planned to fence it with a six- or seven-foot fence with netting connected to the top of the building. Discussion followed.

Supervisor Timmons recommended the area with pitching and the ball cage would be fenced with a six-foot-high fence, and the inside fence would not be necessary.

There being no one further wishing to speak, Chairman Cooper-Jones closed the public hearing.

#### In Re: County Attorney's Report
