


IMPLEMENTING PEC2045: FORWARD TOGETHER

Implementation is comprised of the foundational actions that will bring the Prince Edward County Comprehensive Plan to fruition. The Implementation Plan prioritizes and provides accountability for the strategies listed in Chapters 3 – 8. Specific guidance for decision making is included along with the ongoing process that will be used to monitor progress towards the community's vision for the future.





IMPLEMENTATION TOOLS

The tools listed here are the most important and most frequently used for implementing the strategies of the Comprehensive Plan but many more exist beyond these and should be explored as needed.

ANNUAL

BUDGET

The Board of Supervisors and staff use the recommendations of the Comprehensive Plan to guide preparation of the annual budget. The annual budget is one of the most important tools available for implementing this Plan, as it allocates funding in alignment with the County's priorities.

The budget works in conjunction with the Comprehensive Plan to achieve a thriving and more resilient future for the County.

CAPITAL

IMPROVEMENTS PLAN

The CIP cooridnates capital improvement projects ranked by priority, a year-by-year schedule of project funding, and an estimate of project costs and financing sources. The long-range vision of the Plan is achieved when the priorities of the CIP and ordinance updates align with the Comprehensive Plan.

ANNUAL

REVIEW & UPDATES

To be successful, Prince Edward County will assess the Plan's progress and effectiveness on a regular basis by reviewing and monitoring implementation of the goals, objectives, and strategies outlined within this Plan. This assessment will be part of the annual operating budget and capital improvements planning processes. When appropriate and necessary, the Plan should be amended.

The Board of Supervisors and Planning Commission will carefully consider whether specific amendments are true to the Plan's overarching vision. Any modifications will be considered with long-term policy implications.

LAND USE

REGULATIONS

The Zoning and Subdivision Ordinances, and other land use and development standards and procedures are the primary implementation tools for the Comprehensive Plan. As legal documents, land use regulations outline what uses may occur on the land and how buildings and sites are designed and developed.

Aligning land use regulations with the goals and strategies in this Plan is critical to its implementation. Several objectivesthroughout the Plan include strategies that suggest revisions to the Zoning Ordinance and other considerations for the County's land use regulations. Ordinance revisions will align regulations with Prince Edward County's vision.

LAND USE

ACTIONS

The process for development approval is central to the implementation of the Comprehensive Plan. The Plan serves as a guide for decisions on all land use applications.

Land use applications should be scrutinized for alignment with the Comprehensive Plan, including the specific action strategies and the Future Land Use Map, to ensure consistency. In rare cases where unforeseen uses or changes in market conditions may warrant deviation from the adopted Plan, Planning Commission and the Board of Supervisors should review and consider amendments to the Comprehensive Plan to ensure that the document remains relevant and responsive to the community's needs.

INTERGOVERNMENTAL

COOPERATION

Prince Edward County's success is dependent upon multi-jurisdictional cooperation. Issues with the natural environment, transportation, equity, education, tourism, community facilities, job and workforce development, and many other topics covered in this Comprehensive Plan do not conform to jurisdictional boundaries, and are best solved through cooperation at the regional and state levels.

Successful implementation of the strategies in this Plan will require continued regional cooperation with the Commonwealth Regional Council, Town of Farmville, Town of Pamplin City, and numerous state agencies responsible for various facilities, services, and programs implemented across the state.

IMPLEMENTING PEC2045: FORWARD TOGETHER

PEC2045: Forward Together is Prince Edward County's guide for growth and development. It is intended to be a dynamic document that will change and evolve to reflect the needs of the community. Accordingly, to ensure that this Comprehensive Plan is properly implemented, the Planning Commission and Board of Supervisors should refer to the Plan and consider its vision prior to making recommendations and decisions. Effective implementation of the Plan depends on consistent analysis of each land use application and budgetary decision to ensure compatibility with the long-range vision of the Comprehensive Plan.

The implementation matrix serves as our roadmap for meeting the goals of the Comprehensive Plan. The matrix builds on the strategies throughout the Plan by identifying the tools, resources, responsible parties, cost, and anticipated timeframes for completion. The key to the Plan's success is a proactive approach by the Planning Commission in cooperation with the Board of Supervisors, County departments and boards, residents, businesses, and community institutions and organizations. - Long Actions to be completed within
 5 years of the Plan's adoption.
- Ongoing Actions that should continue for the life of the Plan.

COST

Identifies a general cost estimate for the implementation of a strategy. These cost estimates are categorized as low-cost (\$), medium-cost (\$\$), or high-cost (\$\$\$). Internal policy and land use reviews are examples of low-cost strategies, while capital improvements are considered high-cost strategies. Additional scoping and analysis will be required to determine specific expenses for the implementation of each strategy.

RESOURCES

Identifies examples of community partners, state and federal agencies, and resources that will be necessary to facilitate successful implementation. The identified stakeholders, partners, and resources are meant to be a starting point for implementation. Additional partners and organizations can and should be identified over the timeframe of this Plan. Some strategies in this Plan may reflect an internal policy or function, and may not require external assistance.
