## In Re: Highway Matters

Scot Shippee, PE, Resident Engineer, VDOT, said maintenance continues on pothole patching, shoulder work on secondary roads and putting chip seal on Rustic Rural routes from last year's Secondary Six-Year Plan, and are finishing up the Safety Improvement Project on Route 604, Abilene Road. He said there was a significant issue on Route 460, and VDOT continues to respond to customer service requests.

Supervisor Pride said Darlington Heights Road was in excellent condition and questioned why it was repaved. Supervisor Pride said she telephoned Mrs. Puckett who stated it is part of the maintenance plan and had been approved from the office in Lynchburg. Supervisor Pride asked for clarification on the maintenance plan, how it works and what the next road would be.

Mr. Shippee said these plans are made two to three years in advance. He said the main function of VDOT is to manage the maintenance and the improvement of the primary and secondary roads. He stated the roads are chosen by criteria of Pavement Standards which include pavement testing, pavement ratings, field assessments, inspection of pavement conditions. He said they look at the history of customer service complaints. He said they may change from year to year; VDOT does take input from citizens and the Board but they look at the system as a whole.

Supervisor Pride asked the approximate cost of the repaving. Mr. Shippee said he will have to research to find that amount of that contract. Discussion followed.

Supervisor Timmons stated he has received calls regarding Lakeside Drive; the last topping was put on today. He added that it is about time for the mowing season to begin.

### In Re: Request from American Legion Post 32

Daniel Pempel stated he is a member of the American Legion Post #32 and is requesting the Board's consideration of establishing a WWI monument on the lawn of the Prince Edward County Courthouse. He stated approximately 21-31 soldiers were killed in WWI from Prince Edward County; he said the American Legion would like to have it installed prior to November 18, which is the 100<sup>th</sup> anniversary of the end of WWI. Mr. Pempel said he has been in touch with Simmons Monuments, the same company that made the other monuments on the Courthouse lawn; the proposed monument would have a recessed face with heavy cutting and a smooth finish with the names and the inscription "In Memory of the men of Prince Edward County who made the supreme sacrifice in the Great War 1914-1918." He said it would be 36"-40" wide and the same height as the other monuments.

Supervisor Timmons suggested Mr. Pempel prepare a drawing to submit to the County Administrator.

Mr. Bartlett said the Board adopted a policy which covers how to verify the names to be put on a monument and other standards. Discussion followed.

## Contract for STEPS Centre Roof Replacement

Supervisor Timmons stated the Board discussed the acceptance of a contract for the replacement of the roof at the STEPS building but neglected to vote after entering back into open session.

Supervisor Timmons then said that on Back-Hampden-Sydney Road, there is a section that needs attention and may qualify for safety funds. Discussion followed.

Mr. Shippee said there may be available Revenue Sharing funds which would require a 50% match.

Mrs. Puckett said the section is at the transition point where the paving stopped; the pavement has

no taper onto the older section. Some discussion followed.

Vice-Chairman Wilck opened the public hearing.

Major Constance Owens, Hampton District, stated the bushes along Route 744, Whispering Woods

Road, are overgrowing the road. He said it is blocking visibility and is dangerous.
