• The Committee unanimously recommends that the Board include \$8,500 in the FY 15 County Budget to be used as matching funds for a Rescue Squad Assistance Fund grant application to help

fund vehicle repeaters in the 11 EMS vehicles that serve Prince Edward County. The EMS

are constantly in need of repair and the quality is so poor the documents cannot be scanned by the Clerk of

Circuit Courts new document scanning system.

are forthcoming; the best bid is \$3,495 and based on that bid, \$4,000 will be enough to purchase the copier

and shredder.
